- \*\* NON RESIDENT members are those members 18 years of age or older, who are not full-time students, who have complied with the requirements set out in BYLAWS Section IV, Admission of Members, and whose principal residence is outside a 150 mile radius of Lake Canyon Yacht Club. Anyone owning or residing in a lake house or weekend home within the 150 mile radius does not qualify for NON RESIDENT membership. Spouses shall share the membership.
- \*\*\* STUDENT members are those members 18 years of age or older, who are full-time students, and who have complied with the requirements set out in BYLAWS Section IV, Admission of Members.
- \*\*\*\* JUNIOR members are those members 7 years of age to 17 years of age whose parents/guardians are not Club members and who have complied with the requirements set out in BYLAWS Section IV, Admission of Members. In addition to the requirements in Section IV, the application must include the signature of the applicant's parent/guardian and consent of that person for such background checks as directed by the Board of Governors. Members in this category who are TSA Circuit participants may continue as Junior members through age 19. A Junior member who wants to continue as a member of the Club after expiration of the Junior membership must submit an application for another class of membership.
