Membership Classification Information - Our Club has four categories of memberships for which adults may apply: Senior, Non-Resident, Student, and Individual.

Most people apply for a "Senior" membership using the package on the LCYC web site titled "Membership Packet". This packet is used for all adult categories except Individual. Non Resident membership is open only to those whose principle residence is outside a 150 mile radius of LCYC. Those owning or residing in a lake or weekend home within that radius do not qualify. Non Resident members can not apply for a slip in the marina. Student members must be full-time students.

The "Individual Membership Packet" is appropriate only if the spouse does not intend to be included in the membership. In which case, the spouse and any other family members may only participate as guests of the member. If there is no spouse, we generally recommend selecting the Senior Membership and indicating "No Spouse" on the appropriate line.

A full description of each membership category can be found in our Bylaws - which also appear on the Membership Page of our web site - and on the fee page of this application packet."

- * SENIOR members are those members 18 years of age or older, who are not full-time students, and who have complied with the requirements set out in BYLAWS Section IV, Admission of members. Spouses shall share the membership.
- ** NON RESIDENT members are those members 18 years of age or older, who are not full-time students, who have complied with the requirements set out in BYLAWS Section IV, Admission of Members, and whose principal residence is outside a 150 mile radius of Lake Canyon Yacht Club. Anyone owning or residing in a lake house or weekend home within the 150 mile radius does not qualify for NON RESIDENT membership. Spouses shall share the membership.
- *** STUDENT members are those members 18 years of age or older, who are full-time students, and who have complied with the requirements set out in BYLAWS Section IV, Admission of Members.
- **** JUNIOR members shall be those members seven (7) years of age to seventeen (17) years of age, or who are still enrolled in and attending high school, whose parents/guardians are not Club members and who have complied with the requirements set out in Section IV, Admission of Members. In addition to the requirements in Section IV, the application must include the signature of the applicant's parent/guardian and consent of that person for such background checks as directed by the Board of Governors. Members in this category who are TSA Circuit participants may continue as Junior members through age nineteen (19). A Junior member who wants to continue as a member of the Club after expiration of the Junior membership must submit an application for another class of membership.
- ! INDIVIDUAL members shall be those members eighteen (18) years of age or older, who are not full-time students, and who have complied with the requirements set out in Section IV, Admission of Members EXCEPT that spouses have not complied with Section IV requirements and, therefore, are not members. They may at any time when circumstances so warrant, solicit the Board of Governors to become Senior members. Family Privileges set out in Section X do not extend to Individual members, but use of club facilities is allowed as described in Section XI Guest Privileges.

The insurance carrier for the Lake Canyon Yacht Club has asked that we provide to all our members a list of rules regarding use of the club's swimming pool. The club's pool rules are outlined below:

LCYC POOL RULES

WARNING: NO LIFEGUARD ON DUTY. SWIM AT YOUR OWN RISK.

POOL USE FOR LCYC MEMBERS ONLY. WHEN MEMBERS, THEIR FAMILIES AND GUESTS USE THE POOL, THEY DO SO AT THEIR OWN RISK.

NO CHILDREN UNDER 12 PERMITTED IN POOL AREA WITHOUT AN ADULT. ALL CHILDREN AND NON-SWIMMERS MUST BE ACCOMPANIED BY A PARENT OR RESPONSIBLE ADULT SUPERVISOR.

NO RUNNING OR ROUGH PLAY. RUNNING, BOISTEROUS, OR ROUGH PLAY IS FORBIDDEN IN THE POOL AREA, SHOWERS OR DRESSING ROOMS.

CAUTION: NO DIVING.

NO GLASS IN THE POOL AREA.

NO PETS ALLOWED. DOGS AND OTHER ANIMALS ARE NOT ALLOWED IN THE POOL AREA.

ANY PERSON JUMPING FROM THE CLUBHOUSE UPPER DECK INTO THE POOL WILL BE RESTRICTED FROM THE POOL PERMANENTLY.

LCYC IS NOT RESPONSIBLE NOR LIABLE FOR ANY INJURIES SUFFERED DUE TO A VIOLATION OF THE POOL RULES OR DUE TO PERSONAL NEGLIGENCE.

THE CLUB RESERVES THE RIGHT TO REFUSE ADMITTANCE TO, OR EJECT FROM THE POOL PREMISES, ANY PERSONS FAILING TO COMPLY WITH ANY OF THE ABOVE HEALTH AND SAFETY REGULATIONS.

In addition, the club's insurance carrier has asked that we obtain from each member a signed form acknowledging that they have received and read a copy of the rules. Please review these rules and sign and return the attached form to the club office at your earliest convenience. Thank you for your prompt response.
